



Approved List of Intake Items

| Clothing Item | Quantity Allowed |
|-----------------------------|------------------|
| Shirts/Hoodies | 10 |
| Shoes/Boots | 2 |
| Coat/Jacket | 1 |
| Pants/Sweatpants | 7 |
| Slippers/Flip-Flops | 1 |
| Shorts/Socks/Bras/Underwear | 14 |

Clothing not allowed:

- Solid blue or red clothing (gang-related).
- Billed hats of any kind, du-rags, bandanas (of any color). (Winter hats okay)
- Clothing with chains attached.
- **Clothing depicting profanity, sex, drugs, alcohol, musicians, music, inappropriate phrases.**
- Clothing with movie or TV shows characters/musicians/bands that support an active drug lifestyle.
- Jeans/capris may not have any obscenely revealing holes above the knees. They also cannot have more holes than fabric.
- Shorts may be worn but must not be overly revealing even while sitting.
- Shirts must not reveal cleavage.

Personal hygiene products:

- Clients can bring personal hygiene products such as shampoo, body wash, soap, deodorant etc. Every hygiene product must be approved by a PRP staff member.
- Phoenix Recovery Program provides shampoo, soap, shaving cream and razors.
- **Aerosol products of any kind are not allowed at Phoenix Recovery Programs.**
- Curling irons and hair straighteners are allowed.

Other items that are not allowed:

- **Weapons of any kind:** guns, knives, pocket knives, brass knuckles, chains, screwdrivers, or anything that could be used as a weapon.
- **Pornography of any kind:** movies, magazines, pictures, sexual lubricant, novels that are sexual in context, revealing photographs, etc.
- **Electronics of any kind:** CD/DVD/MP3 players, portable TVs, laptop computers, tablets, cell phones, and hand-held gaming systems.
- **Money is not allowed** at Phoenix Recovery Programs. Clients have no need for money while at PRP.
- **No outside food or drinks.** (candy, pop, chips, cookies, energy drinks etc.)
- **Pens are not allowed**
- **Anything with a motor such as electric tooth brush is not allowed.**
- **Other items may not be allowed if they are deemed a safety or security concern.**

Valuables:

- It is strongly encouraged that clients **DO NOT** bring any jewelry, valuable items and items of sentimental value/irreplaceable items. No family heirlooms or irreplaceable items. Phoenix Recovery Programs is not responsible to replace or reimburse for the costs of lost or stolen items.



Phoenix Recovery Programs Dress Code

All client apparel will be approved by staff before leaving a facility.

- Leggings may be worn with a shirt, skirt, or dress that can provide appropriate coverage.
- Shirts must not reveal cleavage.
- Shorts may be worn but must not be overly revealing, even while sitting.
- Dress/skirts may be worn but must follow the same length requirement as shorts.
- Hoods may only be worn outside. No brimmed hats, du-rags, or bandanas of any kind or color. Stocking caps may be worn provided they do not obscure a client's face in any way
- Jeans/Capris may not have any obscenely revealing holes above the knees. They also cannot have more holes than fabric.
- Pants must be worn at the waist. Undergarments should not be visible.
- Clients must always be wearing shirts. Clients cannot be shirtless or be wearing sleeveless shirts.
- Pajamas are not to be worn outside of the house.
- No solid blue or red clothing article (gang-related).
- Clothing with chains attached are not allowed.
- Clothing depicting profanity, sex, drugs, alcohol, musicians, music, inappropriate phrases.
- Clothing with movie or TV shows characters/musicians/bands that support an active drug lifestyle.
